1	14.11.2025	<p><b><u>JS.J</u></b></p> <p>On 04.09.2025, this Court, in I.A. Nos. 1 and 2 of 2025 in W.P. No. 23631 of 2025, granted interim directions as prayed for.</p> <p>On 24.05.2025, Respondent No. 2, during its General Body Meeting, resolved to host the 63<sup>rd</sup> National Roller-Skating Championship in Visakhapatnam from December 5 to December 15, 2025.</p> <p>On 01.10.2025, the respondents decided to change the venue of the events to the States of Karnataka, Kerala, and Tamil Nadu.</p> <p>The petitioner has challenged the unilateral change of venue in W.P.No.28612 of 2025. This Court, by order dated 16.10.2025, suspended the circular dated 01.10.2025 in I.A.No.1 of 2025.</p> <p>Pending writ petitions, the 2<sup>nd</sup> respondent, through Ref. No. RSFI/PO/2025/10/9 dated 29.10.2025, has unilaterally decided to postpone the events.</p>	

		<p>Learned counsel for the petitioner submits that the petitioner has invested a substantial amount to organize the national events, and furthermore, the Visakhapatnam Metropolitan Region Development Authority (VMRDA) has sanctioned funds and is currently spending about one crore on repairs and renovation of infrastructure for the event. The counsel further submits that due to internal disputes between the 2<sup>nd</sup> and 4<sup>th</sup> respondents, a unilateral decision was taken by the 2<sup>nd</sup> respondent to postpone the event.</p> <p>The event is scheduled to be held from 05.12.2025 to 15.12.2025. Therefore, due to dearth of time, this Court, after hearing the learned counsel for the petitioner and the respondents, in order to resolve the issue amicably, directs the 3<sup>rd</sup> respondent to conduct a meeting with the petitioner and respondents 1, 2, and 4 by issuing urgent notices to them and also to their counsel on record through e-mail/whatsapp, within five (5) days from today, and shall hear the matter independently and take an appropriate decision, in accordance with law, and submit the action taken report before the Court, by the next date of hearing.</p> <p>Post the matter on 27.11.2025.</p> <p>Till such time, the proceedings dated</p>
